REGARDING POWS

853. SHRI V. K. SAKHLECHA : Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether it is a fact that the attitude of Pakistan Government in regard to the joint statement signed by the Government of India and Bangladesh on the issue of the repatriation of Prisoners of war and Bangladesh nationals wishing to return to Bangladesh from Pakistan is disappointing; and

(b) if so, what are the details of the joint statement?]

INCREASE IN PRICE OF COAL IN ORISSA

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND MINES (SHRI SUBODH HANSDA) : (a) and (b)

There is at present no statutory control on the prices of coal. There have, however, been some reports about the increase in the retail price of coal in different regions immediately after the Government take-over of the non-coking coal mines. The increase was not on account of any decision taken either by the Government or the Coal Mines Authority, but to some traders taking undue advantage of the situation arising out of take-over.

(c) The information is being collected and will be laid on the Table of the House.

STAMPS ISSUED BY PAKISTAN POSTAL DEPARTMENT

856. SHRIMATI SAVITA BEHEN : Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether Government's attention has been drawn to the stamps issued recently by the Pakistan Postal Department designed to attract world's attention to Pakistani POWs in India, immediately following the Joint-Bangladesh offer of a solution of the problem of Pak-POWs; and

(b) if so, Government's reaction to the issue of the said stamps ?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) Government have seen reports of Pakistan having issued a stamp on the POWs.

(b) The issue of this stamp is a part of Pakistan Government's propaganda campaign directed against India on the POW question. Government have taken
