

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI DALBIR SINGH) :

(a) Yes, Sir.

(b) A start has been made by appointing a workers' representative on the Board of Directors of the Hindustan Antibiotics Ltd. and the Pyrites, Phosphates and Chemicals Ltd.

In some other undertakings, namely, the Cochin Refineries Ltd., the Madras Refineries Ltd, and the Fertilizer Corporation of India Ltd., the workers representatives have been associated with certain committees like House Allotment Committee, Canteen Committee, Welfare Committee, Works Committee.

EXPANSION OF REFINERIES BY FOREIGN OIL COMPANIES

894. SHRI DEBANANDA AMAT : Will the Minister of PETROLEUM AND CHEMICALS be pleased to state :

(a) whether any foreign oil companies in India have applied to Government for expansion of their refineries; and

(b) if so, the names thereof and the decision Government have taken in the matter ?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI DALBIR SINGH): (a) and (b) : Of the four foreign oil companies owning refineries in India, the Assam Oil Company had earlier applied for the expansion of its refinery at Digboi. The Government did not accept this proposal in the context of the consideration of the overall question of setting up of additional refinery capacity in Assam culminating in the decision to put up a new refinery at Bongaigaon. The other three foreign oil companies i.e. Burmah-Shell, ESSO and Caltex claimed that they have between them spare capacity of about 3 million tonnes per annum. The question of regularly utilising the additional capacity claimed to be available at these refineries will be considered by the Government at the appropriate time when the demand for products in the economic supply areas of these refineries justifies such utilisation.
