IDIKKI HYDRO-ELECTRIC PROJECT

RAQ): (a) As the second stage of Idikki Hydro Electric Project comprises addition of peaking capacity only required for firming up power generation in the Southern Region and will not increase the annual quantum of power generation, the Government of Kerala have proposed to the Government of India to take over the project as a Central Sector Scheme.

(b) The Planning Commission have sanctioned the Scheme for financing from the State Plan resources.

(b) and (c) Till March, 1973 Nylon Units have faced no shortage of Caprolactum. Recently some indications have been noticed that Caprolactum may not be easily available in the world market. Government is seized of the matter and is examining the possible steps to ensure continuity of production of nylon yarn.
