

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI) : (a) Yes.

(b) The Report of the Committet consists of 330 recommendations besides 288 observations. Of the 330 recommendations decisions have been taken on all except two which are still under examination. 245 recommendations have been accepted in full, 50 have been accepted in part or in modified form and 33 have not been accepted. Instructions in regard to the accepted recommendations have since been issued to the Zonal Railways.

NIGHT ALLOWANCES TO CLAIM TRACERS

924. SHRI NAND KISHORE BHATT : Will the Minister of RAILWAYS be pleased to state :

(a) whether it is a fact that the Labour Court, Bombay has given an award to the effect that the Claim Tracers are entitled for the night allowance/overtime; and

(b) if so, whether all the Zonal Railways have agreed to implement the award ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI) : (a) and (b) The orders passed by the Labour Court, Bombay, that in accordance with the Hours of Employment Regulations, necessary credit should be allowed to Claims Tif.ceis when they have to travel in trains on duty and paid overtime whenever it is due to them, have been implemented by the Central Railway. The order did not contain any direction for payment of night allowance.

PROPOSAL TO STREAMLINE ADMINISTRATION OF RAILWAYS

within the present staff structure without any further expansion; and

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI) : (a) and (b) :

Devising of measures to streamline the administration of the Railways with a view to obtaining the optimum results, without disproportionate increase in staff is a continuous process. Mention may be, made in this context of progressively increasing use being made on Railways of modernisation and modern management techniques like work study, operational research, use of computers and mechanisation in various fields of management, operation and maintenance.

Grade have been lying vacant owing to the seniority of Lower Division Clerks having not been finalised.

(e) The seniority list of Lower Division Clerks has since been finalised and D.P.C. is shortly meeting to draw up a list of Lower Division Clerks considered suitable for promotion to Upper Division Grade.
