THE MINISTER OF FINANCE (SHRI Y. B. CHAVAN): (a) The total amount of credits received from the IDA upto the end of 1972-73 is \$ 2014.25 million. These credits carry no interest, but only a serive charge of 3|4 of one percent per annum.

- (b) Agreement for a credit of \$ 21 million was signed on 14th June, 1972 for the implementation of Family Planning Projects in the States of Mysore and UP. Agreement for a credit of \$ 12 million for an Education Project was signed on 10th November, 1972 for the development of Agricultural Universities in Bihar and Assam.
- (c) Several proposals for seeking assistance from International Development Association for implementation of projects in the fields of irrigation, agriculture, rural electrification, ferti-

lisers, livestock, railways, cannal area development are under consideration.
