 - (i) The scheme will be initially introduced between points where container services are already in operation.
 - (ii) The container users would be given a rebate on freight as an incentive for owning containers.
 - (iii) Dimensions and designs of the containers would have to be approved by railways.
 - (iv) The container owners will be normally expected to provide their own transport between the rail container terminal and their premises but in case they so desire, this work may be undertaken by the railwaj's, if possible, on recovery of charges.
