- (a) whether there is any scheme under Government's consideration to introduce "Own Your Container" service on railways; and
- (b) if so, what are the details of this scheme?

THE DEPUTY MINISTER IN THE MINISTRY OF **RAILWAYS** (SHRI MOHD. SHAFI QURESHI): (a) Yes.

- (b) The salient features of the scheme are as follows:---
 - (i) The scheme will be initially introduced between points where container services are already in operation.
 - (ii) The container users would given a rebate on freight as an incentive for owning containers.
 - (iii) Dimensions and designs of the containers would have to be approved by railways.
 - (iv) The container owners will be normally expected to provide their own transport between the rail container teiminal and their premises but in case they so desire, this work may be undertaken by the railways, if possible, on recovery of charges.
 - (v) The container owners would be assured of guaranteed supply of containers up to a fixed number, as mutually decided upon.

The report of the team is expected shortly. The recommendations of the team will be examined and processed expeditiously on receipt.
