IMPORT OF CRUDE OIL FROM IRAQ

Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether Government have concluded an agreement with Iraq for the import of crude oil of a long-term basis;
 - (b) if so, the details thereof; and
- (c) the extent to which India is likely to import crude oil from Iraq during the current financial year and what would be the financial implications thereof?

THE DEPUTY MINISTER IN MINISTRY OF PETROLEUM & CHE-MICALS (SHRI DALBIR SINGH) (a) and (b) A Crude Oil Sale Agreement was

signed between the Iraq National Oil Company and the Indian Oil Corporation on the 4th September, 1972, by which INOC would be supplying 1.95 million tonnes of crude oil to IOC during the period September 1972 to March, 1975.

A Loan Guarantee Agreement was signed between the Government of Iraq and the Government of India on the 6th April. 1973 whereby a credit of US \$50 million in the form of crude oil is being extended by the Iraq National Oil Company to IOC to meet a part of the foreign exchange requirements of the IOC's Mathura Refinery project and allied facilities. A loan Agreement between INOC and IOC in this behalf was also signed on the 6th April, 1973. According to the Agreement, the loan is to be advanced by INOC in the form of North Rumaila crude oil and will be phased over a period of five years. The loan is to be repaid in ten equal annual instalments. INOC have also agreed to supply North Rumaila crude oil for use in the Mathura Refinery annual quantities of not less less than 50 per cent of the refinery's requirements during the period of repayment of the loan.

(c) During the current financial year spn.13 jo sauuoi uoijiji ji inoqu 't/-E/61 oil is expected to be uplifted from Iraq at an FOB cost of approximately \$ 13 million.

THE DEPUTY MINISTER IN 1HE OF IRRIGATION MINISTRY AND POWER (SHRI BALGOVIND VERMA): (a) to (d) The Government of West Bengal forwarded a report on the Upper Kangsabati Project to the Central Water and Power Commission in November. The State Government have stated that they are prepared to take up the execution of the project as soon as the clearance is obtained and necessary funds are made available.

The report is not adequate for being processed further as it does not contain required details of hydrological, topographical investigations etc. The Government of West Bengal have been requested to send a complete detailed report on the project for further processing of the scheme in the CW&PC and the Planning Commission. The CW&PC has been requested to expedite the scrutiny of the project report when received from the State Government and process it through the Technical Advisory committee of the Planning Commission.

FALLOW LAND ALONG RAILWAY TRACKS FOR DISTRIBUTION TO RAILWAY EMPLOYEES ON TEMPORARY LEASE
