in Rangoon, the House was informed that according to our information none of the nationalised industries belonged to Indian nationals. Our Embassy in Rangoon have since informed us that according to the information furnished by the Government of Burma to them, two such industrial concerns belong to Indian nationals. The amount of compensation has not yet been determined as the Government of Burma are taking action to evaluate the assets of all the nationalised industries.

CALLING ATTENTION TO A MATTER OF URGENT PUBLIC IMPORTANCE

DIFFICULTIES FACED BY BUS AND TRUCK OPERATORS IN GETTING TYRE SUPPLIES

SHRI BABUBHAI M CHINAI (Maharashtra) Mr Deputy Chairman, Sir, I beg to call the attention of the Minister of Industrial Development and Science and Technology to the difficulties faced by the bus and truck operators in getting tyre supplies and the steps taken by Government to meet the situation

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVE-LOPMENT (SHRI PRANAB MUKHER-JEE) Mr Deputy Chairman, Sir, Reports and representations have recently been received, especially from State Road Transport Organisations and Private Operators alleging shortage of tyres, particularly truck and bus tyres in different parts of the country

The production of automobile tyres and tubes has steadily increased from 45 79 lakh Nos in 1970 to 49 78 lakh The demand for auto-Nos in 1972 mobile tyres and tubes during 1972-73 is estimated to be of the order of 50 lakh Out of this, demand for truck/ bus tyres is estimated to be of the order of 26 lakh Nos As against this demand, the total production of automobile tyres during 1972-73 is estimated to be of the order of 50 lakh Nos including 26 lakh of truck/bus tyres Though the overall position of supply of tyres is just adequate to meet the demand, there is some marginal shortage in one size of bus/truck tyres viz 900x20 This shortage was estimated during November, 1972 at about 0^0Nos Nos for the whole year. of 11 weeks which had entailed a loss of production to the extent of about 45,000 Nos in this size The recent acute power shortage in various parts of the country has further affected production of this commodity It has been estimated that production during 1973 may be of the order of 56 lakh Nos if there is no power But in case the power shortage continues at the existing rates imposed in the States of Tamil Nadu, Maharashtra and Haryana, the loss of production during the whole year would be about 14 lakh tyres, and about 3 4 lakh Nos in the next 3 months, which would further loss of production of about 1 lakh tyres in size 900 x 20 in the next 3 months. Government have, therefore, decided as an initial step to import 5,000 tyres in the size 900 x 20 from Ceylon to overcome the shortage Further imports will be considered if the Tyle Companies are not able to augment their production in this particular category. The immediate problem of maintaining production arising out of power cut imposed to varying extents in the various States is also receiving attention of the Government by providing power generating sets TELCO have been permitted to import 17,000 tyres pressure in indigenous production would be reduced to this extent

The long-term solution to this problem lies only in stepping up the production of tyres, particularly in the heavier categories
