- (i) Scheme of Pre-examination Coaching for weaker sections including minorities, based on economic criteria for recruitment in services and admission in professional courses.
- (ii) Area Intensive & Madrasa Modernisation Scheme under the Ministry of Human Resource Development.
- (iii) In addition, the National Minorities Development and Finance Corporation (NMDFC) provides loans for the economic empowerment of Minorities and loans for pursuing professional and technical courses.

## **RAJYA SABHA**

- (iv) The Maulana Azad Education Foundation (MAEF) is promoting education amongst the Minorities.
- (v) The Central Wakf Council (CWC) promotes development of urban Wakf properties and educational development.
- (b) The grant released under these schemes along with the number of beneficiaries is given in the statement (see below).
- (c) and (d) The Ministry has received one complaint from Shri Mohd. Shamim Ansari of Begusarai Distt., Bihar, alleging that he is not being able to get loan from Bihar State Minorities Financial Corporation (BSMFC). The BSMFC has been directed to take suitable action in the matter and mitigate the grievances of the applicant.
