- (c) whether it is a fact that controlled varieties of cloth are still not available to the poor masses, particularly those in the remote rural and hilly areas; if so, the steps taken to streamline production and supply of controlled cloth to the public?
- THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A. C. GEORGE): (a) Yes, Sir.
- (b) The quantum of controlled cloth earmarked for being sold through the mills' own retail shops has been increased from 10 per cent to 20 per cent and unlifted cloth is allotted to

- other States which are willing to accept and lift the same immediately or is allotted to be sold through the mills' own retail shops.
- (c) No specific complaints have been received by Government in this behalf.
