

**International cooperation for promotion of Sarva Shiksha  
Abhiyan**

†\*425. PROF. M.M. AGARWAL: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) the names of the countries whose cooperation is being sought to promote "Sarva Shiksha Abhiyan" in the rural areas;

(b) the aid received from the international financial institutions and other countries during the last three years;

(c) the States where this aid has been utilized, district-wise and State-wise; and

(d) the details of the other programmes formulated by Government for promotion of investment in the field of primary education?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (d) A consortium of International Development Association (IDA), Department for International Development, UK (DFID) and the European Commission (EC) is partially funding the Sarva Shiksha Abhiyan (SSA) for the period 2003-04 to 2006-07. SSA is being implemented in all districts of the country except in the State of Goa.

IDA, DFID and the Netherlands are currently funding the District Primary Education Programme (DPEP) in 129 districts of 9 States namely Gujarat, Bihar, West Bengal, Andhra Pradesh, Uttaranchal, Orissa, Uttar Pradesh, Rajasthan and Jharkhand. Shiksha Karmi Project in 150 blocks in 32 districts of Rajasthan is being currently funded by DFID. Another Programme, namely 'Janshala' which was implemented in 139 blocks in 30 districts of 9 States, namely, Andhra Pradesh, Chhattisgarh, Jharkhand, Karnataka, Madhya Pradesh, Maharashtra, Orissa, Rajasthan and Uttar Pradesh, was funded by the United Nations Agencies.
