(c) such other purposes as may be specified by the Central Government from time to time

Of late there has been a reduction on the average in profitability in terms of a percentage of turnover as well as capital employed.

- (c) Yes, Sir. Ma'ny of the foreign firms engaged in the manufacture of drugs have been in existence for a considerable time in India and remittances have been allowed as per policy of Government in this regard. Government have laid down that in the case of 100 per cent foreign owned companies where the declaration of dividends involves drawal from re-services, the remittance facility will be subject to the Reserve Bank of India being satisfied regarding the following:
 - (i) that the reserves have been drawn upon only for maintaining the dividend quantum at the average of the previous 5 years or at 10 percent of the paid ^UP capital, whichever is more;
 - (ii) that the drawal on reserves does not exceed 10 per cent of the total of the paid up capital and free reserves of the company at the beginning of the year; and
 - (iii) that the balance of free reserves left after the drawal does not fall below 15 per cent of the total of the paid up capital and reserves as in (ii) above.
