The techniques being currently introduced include adoption of large size generating units and higher transmission voltages, solid-state protec- . tive relay systems, improved communications including microwave, integrated operation of power systems, wider application of computers including on line computer.

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): (a) and (b) The feasibility of introducing an accident insurance scheme for train passengers is still under examination of the Government.

PROPOSAL FOR EXPANSION OF BARAUNI OIL REFINERY

- 825. SHRI SURAJ PRASAD: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:
- (a) whether tt'iere is any proposal under Government's consideration for the expansion of Barauni Oil Refinery; and
- (b) if so, what are the details in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI DALBIR SINGH): (a) and (b) Barauni refinery (capacity: 3 million tonnes a year) processed about 2.29 million tonnes of crude oil during 1972. A scheme for processing imported crude at Barauni in addition to indigenous Assam crude has been taken up. This

scheme is expected to be completed by March, 1975. This will enable the refinery to reach a processing capacity of 3.4 million tonnes per annum. As an interim measure, processing of imported North Rumalia crude at about 0.5 to 0.7 million tonnes per annum has been started from December 1972.
