Will the Minister of IRRIGATION AND POWER be pleased to state:

(a) whether the target fixed for power generation for the Fourth Five

Year Plan is likely to be achieved; and

(b) if not, what is the likely shortfall and how Government propose to meet the shortfall?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BALGOVIND VERMA): (a) and (b) The latest review indicates that there may be a shortfall of 3 to 3.5 million kW in the Fourth Plan target of installed generating capacity. The following steps have been taken to reduce the shortfall to the extent possible:—

- (i) expediting the delivery of generating plant and equipment.
- (ii) accelerating the progress of Civil works wherever possible.
- (iii) reviewing periodically the progress of manufacture of generating plant and equipment and coordinating them with the progress of civil works.
- (iv) accelerating construction of sanctioned inter-State and inter-regional transmission links to enable transfer of power from surplus areas to neighbouring deficit areas so as to ensure optimum utilisation of the available generating capacity.
