VVUI the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) whether it is a fact that Air India is likely to incur more losses this year than in the previous years;

(b) if so, the reasons therefor; and

(c) what remedial measures Government have adopted to check the losses?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH) : (a) Against an estimated loss of Rs. 3.26 crores when the Budget Estimates were prepared, the loss for 1972-73 is likely to be Rs. 2.92 crores according to the Revised Estimates. The net loss for the year 1971-72 was Rs. 1.66 crores.

(b) the reasons broadly are increased depreciation provisions, insurance premium and interest on loans on three Boeing-747 aircraft during 1972-73 as against one Boeing-747 during 1971-72.

(c) Air-India has taken a number of measures to effect economy in expenditure including a freeze on new recruitment except where absolutely necessary, curtailment of certain services and conversion of some on-line offices to off-line offices, abolition of free ground transport to passengers and very strict control over administrative and publicity expenditure.

#### U.S. TRADE TEAM

(a) whether it is a fact that a US trade team is likely to visit India in April this year;

#### STATEMENT

With reference to parts (a) and (b) of the Question, it may be stated that it was reported in the publication called "Commerce Today" of the US Department of Commerce dated the 8th January, 1973, that a Railway equipment Trade Mission sponsored by the Department of Commerce of USA is expected to visit India during April 1973 to promote sale of US equipment for the Indian Railways. Nothing further in this regard has, however, been heard.

Exports from India to the USA during the period April—August, 1972 amounted to Rs. 119.95 crores, as compared with Rs. 116 crores during April—August, 1971.

Imports from the USA to India during the period April—July, 1972 amounted to Rs. 63.62 crores, as compared with Rs. 155.22 crores during the corresponding period of the previous years.
