THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND IN THE SOCIAL WELFARE OF DEPARTMENT CULTURE (SHRI ARVIND NETAM): (a) and (b) The Board of Control for Cricket in India, is the authority responsible for the conduct of test matches with foreign The Board has confirmed that the Indian players were presented to the Prime Minister in the Delhi test without wearing blazers. This was so because the team consisted of a few players who had been selected to represent India for the first time and had not acquired till the Delhi Test the prescribed blazers. The Board, therefore, decided that instead of presenting some of the players in blazers others without them, all the should be presented to the Prime Minister in sweaters.
