RANA): (a) and (b) The proposals submitted by the Governments of Gujarat and Madhya Pradesh for new additions to the existing National Highway System in their respective states under the Fifth Five Year Plan include, inter alia a request for declaring the Ahmedabad-Jhabua- Dhar-Indore- Dewas- Bhopal route as a National Highway. This route does not touch Alirajpur and Ujjain. This request of the Governments of Gujarat and Madhya Pradesh will have to be considered under the Fifth-Five-Year Plan along with similar other proposals keeping in view the availability of resources, the criteria laid down for declaring roads as National Highways and the inter se priority of this schemes vis-a-vis various other schemes which the other States might submit.]
