given by the World Health Organisation, the optimum requirements work out to 4.25 million units of 250 c.c each. The needs of the Army, Railways and Private Nursing Homes have not been taken into account in arriving at this figure

(b) The present annual collection in the country is between 25 to 3 lakhs units.

(C) Voluntary donors contribute nearly 5% of the blood collected. Constant efforts are made to appeal to the good sense and civic conscience of the people so that a larger number of volunteers is forthcoming Incentives of various types, such as medals, grant ol additional marks to students in annual examinations, special casual leave for blood donors, extra diet to prisoners and remission of their sentence, etc. have been suggested to the State Govts. for their consideration.

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI RAJ BAHADUR) (a) and (b) No, Sir. The losses sustained by the Calcutta Port Commissioners' Railway are mainly due to :----

- (i) Fall in the traffic handled by the Port which is not enough to make full use of the rail facilities provided
- (11) General rise in operating, expenditure.

Some of the losses will be off-set by revision of rates of terminal charges
