#### INFORMAL COMMITTEE OF MEMBERS OF PARLIAMENT

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA) : (a) and (b) Previously there used to be an Informal Committee known as the Prime Minister's Committee of the Members of Parliament on planning. In the meantime, a Parliamentary Consultative Committee on Planning of the Members of Parliament from both the Houses, consisting of various political parties or groups, has been constituted and this Committee meets regularly. In addition it has been decided to hold discussions between the leaders of the opposition from both Houses of Parliament and the Prime Minister along with the other members of the Planning Commission on vital matters related with planning. Accordingly, two meetings with the leaders of the opposition were held recently to discuss the Approach document to the Fifth Five Year Plan and such a dialogue will continue in future as well. Besides the Government has accepted the suggestion made in the meeting with the Leaders of the Oppositions, to have separate discussions with various political party leaders as and when necessary.
