SEMINAR UN PETROLEUM REFINING

- (a) whethe i' a Seminar was recently held in New Delhi on petroleum refining in developing countries;
- (b) if so., the names of the countries who participated in thet Seminar; and
- (c) the de.ails of the recommendations and observations made at the Seminar in regard to India's petroleum refining industry and the reaction of Government thereto?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI D. K. BOROOAH): (a) to (c). A statement h laid on the Table of ihe House. STATEMENT

- (a) Yes. Sir.
- (b) Tlie countries, which participated in the Seminar are Brazil, Burma, Costa Rica, Ethopia, Gautemala. Guyana,: India, Iran, Ivory Coast. Jamaica, Jordan, Kenya. Khmer Republic, Liberia, Malaysia Mexico, Morocco, Panama. Paraguay. Philippines. Sri Lanka, Sudan, Tanzania, Trinidad & Tobago, Togo, Uruguay and Zambia.
- (c) The purpose of the Seminar was to afford an opportunity to developing countries to exchange information and experience on the several aspects, administrative, legal, economic, technical, of petroleum refining. The main suggestions whkh emerged from the Seminar included the setting up of an Information Bureau ior collection, compilation and dissemination of information on all aspects of the oil industry to serve the developing countries, developing suitable machinery to encourage regional and sub-regional co operation among developing countries., to ensure crude oil supplies and bilateral and multi-lateral cooperation between producing and consuming countries leading towards mutually acceptable terrm foi steady 'supplies of oil at reasonable prices. upstream integration, etc. The necessity for an international agency like the U.N. helping the developing countries in overcoming their pressing energy problems was also stressed in the Seminar. Government are generally in agreement with the above suggestions.
