**CALLING ATTENTION TO A MATTER OF URGENT PUBLIC IMPORTANCE**

**HEAVY LOSS OF HUMAN LIVES AND PROPERTY CAUSED BY RECENT UNPRECEDENTED FLOOD IN TAMIL NADU**

**श्री जगदीश प्रसाद माथुर (राजस्थान) :**

**THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BAIJNATH KUREL) :** Sir, a severe cyclonic storm with an inner core of hurricane force wind (118 km. per hour and more) hit the Tamil Nadu coast near Cuddalore at 5 A. M. on December 6. After crossing the coast, it weakened into a depression and moved across the Peninsula and emerged into the Arabian Sea off Mysore-
