(b) by when all these applications will be cleared; and

(c) the steps being taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI TAPAN SIKDAR): (a) 11164 PCO, STD/ISD booths have been installed in Bihar during the last three years;

(a) The number of applications pending telecom distrsict-wue, for allotment of PCO booths is given in the Statement. (*See* below).

(b) The pending applications are to be cleared progressively by March, 2001.

(c) The steps taken to clear the pending applications include augmentation of exchange capacity, expansion of outdoor network, augmentation of STD junctions etc.

Opening of Post Offices in Adivasi areas of Maharashtra

3147. SHRI SURYABHAN PATIL VAHADANE: Will the Minister of COMMUNICATIONS be pleased to state:

(d) whether Government are contemplating and set up new Post Offices/sub-Post offices for strengthening the postal services in Adivas¹ areas of Maharashtra;

(e) if so, the details thereof; and

(f) if not the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI TAP AN SIKDAR): (a) Yes, Sir.

(a) The details of Post Offices in Tribal areas of Maharashtra as on 31-3-2000 are given in statement (*See* below). It is also proposed to open 12 more Extra Departmental Post Offices in Tribal Areas of Maharashtra Circle during the current Annual Plan. However, Post Offices are opened as and when they are justified subject to departmental norms. This is further subject to sanctioning of required number of posts by the Ministry of Finance.
