THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRIKONDAJI BASAPPA: (a) and (b) Yes, a population Project is to be implemented in the States of Mysore and Uttar Pradesh for a period of five years. For implementation of this Project, an agreement has been entered into between the International Development Association, and Sweden on the one hand and the Government of India on the other. The total assistance will be US \$31.8 million (equivalent to about Rs. 23 crores) of which \$10.6 million will be by way of grant from Sweden and \$21.2 million by way of a loan from International Development Association on easy terms. The Project will cover six districts of Uttar Pradesh (viz. Sultanpur, Muzaffarnagar. Pralapgarh, Rae Bareli, Lucknow and Saharanpur) and fivC districts of Mysore (viz. Ba ng;; I ore, Tumkur, Shimoga, Chitradurga and Kolar). The normal Government of India

programme will continue to be operated in those districts. Besides, there will be special maternity centred programmes in the cities of Bangalore and Lucknow an intensive programme in two districts each out of the project districts of Mysore and Uttar Pradesh. A nutrition programme will also operate in one intensive district each of these States. An information and evaluation system will be an important ingredient of this action-<vw;-research oriented projects.
