## DEVELOPMENT OF HAUZRANI VILLAGE TN SOUTH DELHI

- (c) the total area, if any, that has got to be vacated on account of implementation of this development; and
- (d) the amount allocated for development of the above area and the amenities sought to be provided during the year 1973-74?
- THE MINISTER OF WORKS AND HOUSING (SHRI BHOLA PASWAN SHASTRI): (a) 1st September, 1962 i.e. the date of commencement of the Master Plan for Delhi.
- (b) The development plan prepared by the Delhi Development Authority was sent to the Municipal Corporation of Delhi for approval and implementation. The Corporraiion is putting up the plan to their Standing Committee for approval.

- (c) The development plan covers 16.78 acres. Out of this, 7.03 acres is earmarked for community facilities like roads, lanes, nursery school etc. For providing these facilities, few structures outside the old abadi, will be affected and will require removal. No structures will be affected in the remaining area of 9.75 acres.
- (d) As the plan has not yet been approved, the Corporation has not made specific provision for this village in 1973-74.
