bonded agricultural labour, in certain areas of the Mysore State. A copy of the Report of the Committee was placed before the Rajya Sabha on 6th May. 1969. The Commissioner for Scheduled Castes and Scheduled Tribes also mentioned the exist-ance of this form of bonded agricultural labour in Mysore, among other States.

The matter has been taken up with the State Governments.
