INDIA SUPPLY SERVICE

- 1438. DR. BHAI MAHAVIR: WiH the Minister of SUPPLY be pleased to state:
- (a) whether Government have declared India Supply Service (I.S.S.) as a technical
- (b) if so, the details of the technical qualifications prescribed by Government for I.S.S. personnel who are appointed as Dy. Director, Director and D.D.G. in the Offices of the DGS & D and I.S.M., London and Washington: and
- (c) if not, the precise reasons for the appointment of I.S.S. personnel to such posts ignoring the legitimate claims of the employees belonging to other services who are working in the same Department or elsewhere in Government of India?

THE MINISTER Of SUPPLY (SHRI SHAH NAWAZ KHAN): (a) and (b) The Indian Supply Service is a technical service in the sense that except 'for a very smaAl promotion quota only persons ' with techniaai qualifications are recruited to this service. Direct recruitment is made only to the lowest grade of the service viz., Grade III, through the Combined Competitive Examinations oanducted by the UPSC for recruitment to the Engineering Services (Class I). The technical qualifications prescribed for candidates for eKgdbiMty to take this examination is a degree in various branches of engineering. The posts of Deputy Director, Director and Deputy Director General which are Grade II, Grade I and Super-time scale posts of this service, are filled IOO per cent by promotion from the lower grades.
