CONTRACT TO JAPANESE FIRM FOR EXPANSION OF TISCO

(a) whether the work relating to preparation of the project report for expansion of the Tata Iron and Steel Company's production capacity has been assigned to a Japanese firm; if so, on what terms;

(b) what efforts, if any, were made to secure such expert services for preparation of the project report In-dignously and with what results? and

(c) whether any global tenders were invited for the job; if so, the result thereof?

THE MINISTER OF STEEL AND MINES (SHRI S. MOHAN KUMARAMANGALAM): (a) to (c) A 'Statement is laid on the Table of the House.

STATEMENT

(a) The question of a project report has not arisen so far. Government have approved the preparation of a feasibility study by Nippon Steel of Japan, to determine how best to increase the capacity of the steel plant of TISCO at Jamshedpur, from its existing level of two million tonnes of ingots a year to four million tonnes or more and achieve this most economically and expeditiously. The study is being commisc:oned and paid for by TISCO. A fee of Rs. 35 lakhs is payable to Nippon Steel and in addition, the rupee expenses on living and travel of their experts in India are also to be met by TISCO.
