- (c) whether any global tenders were invited for the job, if so, the result thereof?

STATEMENT

(a) The question of a project report has not arisen so far. Government have approved the preparation of a feasibility study by Nippon Steel of Japan, to determine how best to increase the capacity of the plant of TISCO at Jamshedpur, from its existing level of two million tonnes of ingots a year to four tonnes or more and achieve this most economically and expeditiously. The study is being commist oned Rs 35 paid for by TISCO A fee of lakhs is payable to Nippon Steel and in addition, the rupee expenses on living and travel of their experts in India are also to be met by TISCO.
