Coal Mines Wage Board recommendations, payment of dues and reopening of the closed mines in 1972 and upto 15 February, 1973. There was one hunger strike and o'ne relay Dharna before the office of the Regional Labour Commissioner (Central), Asansol.

SHRi KALYAN ROY: Sir, now that all the non-coking mines have been taken over by the Government of India and have come under the Coal Mines authorities, yet it is found that a large number of mine-owners did not pay the monthly wages for September, October, November and December, as also the bonus. Have the Labour Ministry which is looking after the payment and other aspects of coal-mine owners, taken up with the Coal Mines authorities, in order to make them pay the arrears of salary and bonus and, if so, what is the result?

MOHAN FUMAIRA-SHRI MANGLAM. The hon. Mtmbbr should be aware because he wag present at the meeting when this matter was discussed. The unions also had been asked to give the details to the coal mines authorities as to what were the arrears due and the coal mines authorities would do their best to take the necessary action. Obviously, it is difficult to collect all this information. If t'he unions cooperate with the Custodians in making their assessments of what is due, then the necessary steps can be taken.

SHRI KALYAN ROY: I am putting the second question. 1 expected the answer from Mr. Raghunatha Reddy.

MR. CHAIRMAN: You cannot prescribe who is to answer. Kindly put your question.

SHRI KRISHAN KANT: The Labour Minister and the Steel Minister are very cooperative in the House. The ofher day also, a question was put to the Labour Minister and the Steel Minister answered it. The other Ministers can also follow this.

SHRI KALYAN ROY; The Labour Minister has stated that the hunger strike took place against the illegal closure of a large number of coal mines. May I know, since the Coal Mines Authority took over in January 31, 1973, i.e. 2J months ago, if a single closed mine has been opened and. if so, which is that coal mine?

SHRI S. KUMARA-MOHAN MANGALAM: the Again hon Member is more acquainted with the facts and what happened after the takeover than I am. I will have to bring back to his memory- • I do not know if his memory has become a little Ifeeble-that when he discussed this with me, the other union leaders and the Custodian General of the Coal Authority in Asansol in February, it was decided that a small committee s'hould be set up to go into this question of the reopening of the closed mines. I believe that out of 5 mines which were closed recently, a decision was taken to open 2 mines. So far as the 3 mines were concerned, I believe that it wa3 found that there was not enough coal to be mined. I was not there. Well, it is open to the r n. Member to find it out from the Coal Mines Authority. He is in contact with them. Would it not be better if he got the information from the horse's mouth?

SHRI BHUFESH GUPTA: He says, he should get it from the horse's mouth. I understand that Mr. Mohan Kumaramangalam is not a horse.

Will the Minister of EXTERNAL AFFAIRS toe pleased to state:

- (a) whether it is a fact that Shri S. A. Dange, Chairman of the C.P.I, was invited to attend and speak at the Kremlin on the occasion of the 50th anniversary celebrations of the founding of the Soviet Union, alongwith India's official representative:
- (b) if GO, what is the reaction of Government thereto;
- (c) whether the speeches made by the leader of the official delegation and the Communist Party delegation were diverse in their content and approach; and
 - (d) if so, Government's reaction thereto?]

THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH): (a) Yes, Sir.

- (to) The celebrations in Moscow were organised jointly by the Central Committee of the Communist Party of the Soviet Union, the Presidium of the Supreme Soviet of the USSR and the Council of Ministers of the USSR and invitations were issued jointly by them. The Government of India saw no objection to this.
- (c) and (d) The speech of the Vice-President was on behalf of the Government of India, whereas the speech of Shri S. A. Dange represented the view-point of the Communist Party of India. It fa well known that the views of the Government of India and those of the CPI are not identical on all matters.

Leaders of political parties in India are free to express their views which may be different from the position of Government. 33

SARDAR SWARAN SINGH: I Will request t'ne hon. Member not to bring in the high ottice of the Vice-President when he puts forward a question of that nature. What he is trying to say is that the views contained in Mr. Dange's speech are different from the views of the Government. I have admitted that already. But our system is such that the views that are different from the views of the Government are expressed. We want that this tendency should remain inside the country and we would very much appreciate if our political parties, particularly those who are opposed to us, do not air their views which they know are different from ours whenever they go abroad. But if they do, well there is precious little that we can do.

DR. BHAI MAHAVIR: The question was not about the difference in the views. The question was, it was revolting to the dignity of the official delegation. Number 2; Is it the Government's...

SHRI BHUPESH GUPTA; On a point of order... (Interruptions). Point of order.
