In the case of fertilisers, the requirements are assessed according to targets of consumption as fixed by Agriculture Ministry and Planning Commission in consultation with State Governments. After taking into account the domestic production, the net deficit is met by imports from abroad. Imports in turn depend upon availability of necessary foreign exchange with us and of exportable surplus of fertilize s in International markets. Government of India have, keeping in view the requirements of the country, authorised imports of fertilizers accordingly.

(b) The details of tractors to be imported (country-wise and makewise etc.) have not yet been finalised.

As regards fertilizers, contracts have been entered into for supply from the .following countries:

Poland, U.S.S.R., Bulgaria, Rumania, GDR, Taiwan, South Korea, Saudi Arabia, Kuwait, Italy, U.K., Holland, (Belgium, U.S.A., France, Federal Republic of Germany, Canada, Japan, Mexico, Finland, Congo and Burma.

(c) Except for delay in the ship ment of part of the quantity from four countries, all the other supplies have been timely.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (PROF. SHER SINGH): (a) and (b) The programme of Haryana Government to import Diesel Generating seta has received attention of the Government of India and after due examination, the Government of India has permitted Haryana Government to import two sets of 3.5 M.W. each from the U.S.S.R.—a rupee trade country, to meet the acute power shortage prevalent in the State for agricultural purposes. Additional requirement of Diesel Generating sets is to be met from indigenous sources by the State Government.
