SHRI OM MEHTA: He can continue after lunch.

MR. DEPUTY CHAIRMAN: He was in the middle of his speech; I think he was about to finish. It is but fair that he should be allowed to finish.

SHRI MAHAVIR TYAGI (Uttar Pradesh): We are sitting up to six and there should be some gap for lunch.

SHRI LOKANATH MISRA: We can have half-an-hour for lunch and we shall sit on Monday.

MR. DEPUTY CHAIRMAN: Is it he wish of the House? Are you agreed Dn that?

(No hon. Member dissented)

MR. DEPUTY CHAIRMAN: We can have half-an-hour lunch. Let him finish his speech.

Sir, in conclusion I say and emphasise that if mineral production does not increase, I am afraid we cannot industrialise our country. And we should also bear in mind that the minerals, our national wealth, should be exploited for the good of the nation, and not for the good of a few people.
