(a) to (f) National Highway No. 10 in Delhi starts from the junction of Ring Road with Rohtak Road. No proposal to construct or develop National Highway No. 10 as such along the existing old Rohtak Road is, therefore, under consideration of the Government of India in the Fourth Five Year Plan. No proposal or report has been submitted regarding this National Highway to the Planning Commission on 30th September, 1972 by the Government of India. The Old Rohtak Road in Delhi, which is not a National Highway, vests with the Municipal Corporation of Delhi which is a statutory body and it is, therefore, for them to take remedial measures for removing heavy rush on the existing Old Rohtak Road.
