the Planning Commission, to open Agro-Service Centres all over the country has been shelved by Government; and

(b) if so, the reasons for the same?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB SHINDE): (a) No Sir, the scheme has not been shelved. The scheme of Agro-Service Centres is being implemented on a priority basis. 732 Engineers! Diploma Holdlers have already completed their training. 308 are .now undergoing training. Of the 732 entrepreneurs already trained, 366 Engineers have established Agro-Service Centres in the various States.

## VISIT OF -RAJASTHAN BY CENTRAL STUDY TEAM

- 1667. SHRI M. K. MOHTA: Will the Minister of AGRICULTURE be pleaised to state:
- (a) whether it is a fact that ac cording to the Central Study Team Rajasthan's drought which visited recently, affected areas famine and drought conditions in certain parts of the State are "critical" and that the food supply inadequate to to meet the requirements; and
- (b) if so, the details thereof and the steps taken by Government to meet the food deficiency and to im prove the situation?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB SHINDE): (a) and (b) The report of the Central Study Team which visited Rajasthan in February, 1973 is awaited. However, some parts of Rajasthan have been severely hit by drought this year. Necessary measures have been taken by the State Government to maintain drinking water supply, availability of fodder, public health and to provide employment to the affected population. Reasonable requirements of foodgrains

in the affected areas are being met. Additional quantities of foodgrains have been allotted on the basis of assessment recently made. Against the ceiling of expenditure for central financial assistance of Rs. 6.60 crores fixed, an amount of Rs. 5 crores has been released to the State Government so far.

Fifteen thousand tonnes of wheat and five thousand tonnes of milo have been allotted to the State Government for March, 1973.
