- (b) whether it is also a fact that this disease has become very common among the children in the country; and
- (c) if so, what steps Government have taken to prevent this disease?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI A. K. KISKU):
(a) No exhaustive surveys have been undertaken. But a few individual and sporadic studies under the auspices of Indian Council of Medical Research have been carried out on the prevalence of rhuematic and other types of heart diseases. The Indian Council of Medical Research has also initiated a collaborative study on the epidemiology of heart diseases at Bombay, Alleppy, Hyderabad, New Delhi, Agra and Calcutta.

- (b) In the absence of any survey, no figures are available.
- (c) Ordinary facilities for treatment of the disease exist in all the hospitals and specialised facilities are available in all the major hospitals.

SMALL FARMERS NOT BENEFITED . BY COOPERATIVE BANKS

1542. SHRI N. R. CHOUDHURY: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether it is a fact that Small Farmers are not being benefited by the co-operative banks because of the strict considerations of credit worthiness;
- (b) if so, whether Central Government have issued direction to the State Governments to consider actively to give guarantee to the co-operative banks for giving credits to the small farmers; and
 - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB SHINDE): (a)

to (c) Short term loans without any limit for production purposes, mediumterm loans upto Rs. 3,500 for minor irrigation purposes and purchase sprayers, medium term loans upto Rs. 2,000 for dairy and poultry can be given by cooperatives, without mortgage of land as security. Cooperative Land Development Banks long-term loans on mortgage of land. Development Banks provide long-term loans on mortgage of land. banks have been advised assess the crop production and income generated by the proposed investments and grant loans on that basis rather than on value of security. SFDA/MFAL areas, Risk Fund contributions are being provided to cooperatives to encourage them to lend to the weaker sections in a measure. Subsidies on capital investment are also being provided under those two Central Sector schemes to reduce the loan burden. The Government of Gujarat had issued general orders guaranteeing the deficit in security for long term loans by Development Banks for all Small Farmers and Marginal Farmers State. Government of India had commended this to other States for emulation.

†[FARE CHARGES BY MINI BUSES PLYING IN DELHI

1543. SHRI SURAJ PRASAD: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether it is a fact that the private bus owners who were permitted to ply mini buses in Delhi are charging fair at double the rate in comparison to the Government buses; and
 - (b) if so, whether the Government have instructed the private bus owners to charge the same fare as is charged in the Government buses, and if not, the reasons therefor?]

नौवहन ग्रौर परिवहन मंत्रालय में राज्य मंत्री (श्री एमः बी॰ राणा) : (क) जी, नहीं। प्राइवेट चालकों द्वारा चलाई जा रही मिनी बसों और दिल्ली परिवहन निगम की बसों के किरायें में कोई ग्रन्तर नहीं है। इनमें वे पाच बसें शामिल नहीं है जो कि 1968 से उक्त निगम द्वारा दिल्ली के स्रंदर-स्रंदर चलाई जा रही है श्रीर जिनका किराया श्रनुसूची अथक है । राज्य परिवहन पाधिकारी, दिल्ली द्वारा शहर के बाहर मिनी बस का 7 किलोमीटर तक निर्धारित न्युनतम किराया 35 पैसे है, ग्रौर उसके बाद प्रत्येक ग्रतिक्क्ति किलोमीटर के लिए 5 पैसे है, श्रीर श्रधिकतम किराया एक रुपया है। शहर के म्रंदर चल रही दिल्ली परिवहन निगम की बसों के बारे में 3 किलोमीटर की दूरी तक अनुमोदित न्यूनतम किराया 20 पै से है भ्रौर उसके बाद प्रत्येक ग्रतिरिक्त किलो-मीटर के लिए 5 पैसे हैं, अधिकतम किराया 50 पैसे है।

†[THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI M. B. RANA): (a) No, Sir. There is no difference in the fares of mini buses run by private operators and those run by the Delhi Transport Corporation, except in respect of five such buses being operated

by the said Corporation inside the walled city of Delhi since 1968, for which the fare schedule is different. The minimum fare for a mini bus outside the walled city as fixed by the State Transport Authority, Delhi, is 35 paise upto a distance of 7 kms, and, for every additional km. thereafter, the charge is 5 paise; the maximum fare is Re. 1/- In respect of the D.T.C mini buses operating inside the walled city, the approved fare structure is a minimum of 20 paise upto a distance of 3 kms. and, for every additional km, thereafter, 5 paise. The maximum fare is 50 paise.

(b) Does not arise.]

DEVELOPMENT OF WRAPPER TOBACCO

- (a) whether it is a fact that Government scheme on the development of wrapper tobacco cultivation has been taken up in West Bengal; and
 - (b) if so, the result of the scheme?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB SHINDE): (a) and (b) A Centrally Sponsored Scheme for demonstration of Wrapper Tobacco cultivation in West Bengal has been taken up since 1970-71. The results so far obtained indicate that the quality of tobacco grown under the Scheme is satisfactory for exports.
