TELEX EXPANSION PROGRAMME

- (a) whether it is a fact that a Telex Expansion Programme has been formulated for re-inforcing the Telex services in the country,
- (b) if so, the details of the programme and its financial and other implications?

THE MINISTER OF COMMUNICA-TIONS (SHRI H N BAHUGUNA) (a) Yes, Sir

(b) At prosent telex service is available at 41 stations in the country. It is proposed to commission 13 more telex exchanges by end of 1973/74. In the draft fifth plan provision has been made for adding 30 more exchanges. Provision made for telex in the fourth plan is Rs 40 crores and in the fifth plan Rs 35 crores.

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA) (a) The Central Statistical Organisation's figure of net national product released through the press note on 'Quick estimates of

national income' and reproduced by the Ministry of Finance in its 'Economic Survey' for 1971-72, is based on the 1960-61 prices, whereas the Plan estimate appearing in the "Fourth Plan Mid-Term Appraisal" (Vol. I), is based on the 1968-69 prices. The two estimates are not comparable.

RATIONAL DISTRIBUTION OF ELECTRO-NIC INDUSTRY

*73. SHRI SARDAR AMJAD ALI: Wifl the Minister of PLANNING be pleased to state:

- (a) whether the Planning Commission have made any study for a rational distribution of electronic industry all over the country;
 - (b) if so, the details thereof; and
- (c) what steps have so far been taken in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA): (a) to (c) Planning Commission have set up a Task Force for suggesting a complehensive programme of development of the electronics industry during the Fifth Plan period. The terms of reference of the Task Force include recommendations on capacity and production targets by 1978-79 and also the most advantageous way of securing these targets whether in terms of expansion of existing units or through establishment of new units with due regard to the technological developments. The report of the Task Force is expected shortly.

The desirability of regional dispersal of this industry, both in the large and small scale sectors will be taken into consideration by the Government while approving the setting up of new units.

ESCAPE OF CONVICTS FROM TIHAER
JAIL, DELHI

*74. SHRIMATI SITA DEVI: Will the Minister of HOME AFFAIRS be pleased to state:

- (b) The Delhi Administration has reported that three convicts including one convict official escaped from the Jail Farm where they had been taken to work in a convict gang. Two of the convicts including the Convict official were re-arrested on 24-12-1972 and 28-12-1972 respectively. The Delhi Police are making efforts to trace out the third convict.
- (c) The Warder Incharge of the convicts on the day of the incident has been placed under suspension.
