- (b) The need to have mass contacts is kept in view while imparting training to police officers. Also, the Government had set up a Committee, under the Chairmanship of Professor M. S. Gore to examine the objectives which should govern all arrangements for the training of Police Officers. The Committee has submitted its report and its recommendations including the recommendations on mass contacts is under examination of the Government.
- (c) Instructions have been issued to the beat duty constables, the Mobile Wireless Vans staff and the Sub-Divisional Police Officers to have mass contacts in course of their duty. These instructions have been periodically repeated.]

#### TELEPHONE CONNECTIONS TO TENANTS IN CALCUTTA

# 234. SHRI K. P. SINGH DEO: DR. R. K. CHAKRABARTI:
