AND SUBRAMANIAM): (a) to (c) Industrial Licensing Policy Inquiry Committee has in its report referred to certain instances of irregularities, lapses and improprieties said to have taken place in the matter of grant, utilisation or implementation of industrial licences but had not specifically reported on the The Government persons responsible. have appointed a Commission of quiry for investigating among the instances of irregularities, lapses and improprieties brought out in Committee's Report. According to its terms of reference, the Commission has been requested to report on the cumstances in which such irregularities, lapses or improprieties occurred or persons the concerns, institutions responsible therefor. A copy of the notification giving the terms of reference of the Commission was laid on the Table of the House as an enclosure to the answer given to Unstarred Question No. 17 on 23-2-70.
