SETTING UP OF A T.V. PLANT IN ORISSA

1650. SHRI N. R. CHOUDHURY : Will the Minister of ELECTRONICS be pleased to state :

(a) whether it is a fact that the Industrial Development Corporation of Orissa has accepted the terms of Hindustan Aeronautics Ltd., for giving technical know-how in setting up a TV plant in the State; and

(b) if so, what are the details regarding the location and cost and by when it is likely to start functioning ?

THE MINISTER OF ELECTRONICS (SHRI K. C. PANT) : (a) and (b) A letter of intent was granted on 21-3-1972 to the Industrial Development Corporation of Orissa for putting up a TV plant of capacity of 5,000 sets per annum. The Government of Orissa have now indicated that they propose to implement the project through the Orissa Small Industries Corporation. A proposal for obtaining technical know-how for the project from Hindustan Aeronautics Ltd. is under consideration of

the State Government, as also other details regarding its location and cost. It is not possible at this stage to indicate precisely when the unit would go into production.
