- (d) Government has already laid down the policy to be followed by Public Sector Undertakings in the recruitment. According matter of to this policy vacancies of unskilled and skilled workers, Clerks and other staff scales non-technical whose are comparatively low are required to filled through recruitment from employment exchanges functioning close to the Project.

In recruitment to such posts, preference is also required to be given to persons displaced from the areas acquired for the project or Scheduled Castes and Scheduled Tribes (e.g. Ad-ivasis) and to those, who even if they come from some distance, have been or are about to be retrenched from other Government Undertakings so long as the basic qualifications and experience are forthcoming.

In the case of middle level technical and non-technical posts having higher starting salaries equivalent to the Class I junior scale of the Government, recruitment is required to be made on an All India basis, merit and qualifications being the principal criteria.]
