SERVICE RULES FOR THE STAFF OF THE TUBERCULOSIS CENTRE, MADRAS

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI A. K. KISKU): (a) and (b) Tuberculosis Chemotherapy Centre, Madras is a permanent research institute under the Indian Council of Medical Research. It has been decided to convert 80% of such of the temporary posts in the headquarters/permanent Institute of the Indian Council of Medical Research into permanent ones as have been in existence for more than 3 years and are likely to continue on a long term basis. The question of granting pensionary benefits to the staff has, however, not yet been decided.
