THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI OM MEHTA): (a) Yes, Sir.

- (b) The members of the Departmental Promotion Committee are nominated by designation. The present composition of the Committee for selection of Junior Engineers to the grade of Assistant Engineer is as follows:—
 - (i) Engineer-in-Chief, Central Public Works Department.—Chairman
 - (ii) Deputy Secretary (Establishment Works), Ministry of Works & Housing.— Member
 - (iii) Director of Administration Central Public Works Department.— Member

The post of Assistant Engineer which is a Class II Gazetted post is a selection post and the Committee therefore adopts the criteria merit-cwi»-seniority laid down for selection posts.

- (c) and (d) As the post of Assistant Engineer is a selection post for Junior Engineers, the officers are placed in select list in order of comparative merit. As officers of superior merits were available in sufficient number, officers with lesser merits were not included in the select list by the Departmental Promotion Committee. The impression that the personnel with adverse reports can only be superseded, for selection posts is not correct.
