(a) whether financial assistance is being provided to sports persons under the scheme, National Welfare Fund for Sports Persons;

- (b) if so, the details thereof along with the number of sports persons provided assistance during each of the last three years, State-wise and discipline-wise; and
- (c) the criteria being adopted by Government in providing funds under National Welfare Fund Scheme for Sportspersons?

THE MINISTER OF STATE IN THE MINISTRY OF YOUTH AFFAIRS AND SPORTS (SHRI PRATIK PRAKASHBAPU PATIL): (a) Yes, Sir.

- (b) The details of the sportspersons assisted under the Fund during last three years are given in the Statement (See below).
- (c) A sportsperson or his/her family in living in indigent conditions with an annual income of less than Rs. 2 lakh is eligible for consideration. Only those sportspersons who have achieved positions within first three in individual events or within first 2 in team events in a recognized National Championship, or one who has represented the country in an international competition at least twice, would qualify for assistance under the Scheme. However, the Minister-in-charge of the Ministry of Youth Affairs and Sports has discretionary powers to relax the eligibility conditions in deserving cases.
