- (a) whether it is a fact that Indian Olympic Association has finally decided to bid for the 2019 Asian Games;
- (b) if so, whether IOA's proposal requires prior approval of Government being funds provider and infrastructure and physical facilities are created through Government agencies on the land so identified, and getting clearance from many Government authorities; and
- (c) whether the aberrations faced for hosting Commonwealth Games be adequately taken into account to eliminate their recurrence?

THE MINISTER OF STATE IN THE MINISTRY OF YOUTH AFFAIRS AND SPORTS (SHRI PRATIK PRAKASHBAPU PATIL): (a) and (b) No, Sir. Letter of support from the Government is a necessary prerequisite for any National Olympic Committee to bid for the Asian Games.

(c) The Government will take on board the recommendations of the High Level Committee constituted under the Chairmanship of Shri V.K. Shunglu to look into issues relating to organizing and conduct of the Commonwealth Games, 2010 and the lessons learnt for the future, and the findings of Comptroller and Auditor General (CAG), Central Vigilance Commission (CVC) etc. before agreeing to host similar international sporting events, including Asian Games.
