- (iv) Upgradation of about 20,000 kms of single/intermediate lane National Highways to 2- lanes with paved shoulders under NHDP Phase IV.
- (v) 6 laning of around 5000 kms under NHDP Phase V.
- (vi) Identification and construction of around 1,000 km Expressway under NHDP Phase VI.
- (vii) Construction of bypasses, flyovers, ROBs etc. at required locations under NHDP Phase VII.

MUNIYAPPA): (a) and (b) Four-laning of National Highway-11 from Km. 246/300 to Km. 250/100 of Jaipur-Chomu section has been sanctioned for Rs. 4.996 crore in March, 2005. The balance length of Jaipur-Chomu section of National Highway-11, Jaipur to Chaksu section on National Highway-12 and Kishangarh to Byavar section on National Highway-8 have been identified for four-laning on Build Operate and Transfer (BOT) basis under National Highways Development Project (NHDP) Phase III.

## Monitoring of Road Safety in Andhra Pradesh

MUNIYAPPA): (a) As per Section 3(3) of the National Highways Authority of India Act, 1988, the Authority shall consist of a Chairman, not more than five full time Members, and not more than four part time Members, to be appointed by the Central Government.
