- (b) if so, the reasons for not taking a decision on each of the important recommendations even after a long gap even when these issues are being debated everywhere right from the Parliament to the Supreme Court;
- (c) whether Government has formulated any time-frame for taking a final decision on these recommendations of TRAI;
 - (d) if so, the details of the same; and
 - (e) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI SACHIN PILOT): (a) Sir, Telecom Regulatory Authority of India (TRAI) had submitted its recommendations dated 11.05.2010 on 'Spectrum Management and Licensing Framework' and recommendations dated 06.08.2008 on 'Mobile Virtual Network Operators (MVNO)'.

- (b) The recommendations on MVNO were examined by the Government wherein certain recommendations were referred back to TRAI for reconsideration. While the matter was being examined for preparation of detailed guidelines for MVNO, TRAI issued its Recommendation on 'Spectrum Management and Licensing Framework'. In view of the new licensing framework recommended by TRAI, it has been decided to seek the TRAI's opinion regarding MVNO after the decision of the Government on the said recommendations of TRAI on 'Spectrum Management and Licensing Framework' so as to avoid any contradiction in policy implementation. As far as the recommendations on 'Spectrum Management and Licensing Framework' are concerned, the TRAI has further, on 18.05.2010, requested the Government to await its recommendations on spectrum pricing and refarming. The Government has already constituted a Committee under the Chairmanship of Member (Technology), Telecom Commission to examine these recommendations.
- (c) to (e) Being a matter of policy formation, which also requires inter-ministerial consultations, it is not feasible to specify a time frame.

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI GURUDAS KAMAT): (a) to (c) Department of Posts has covered all Head Post Offices in Orissa Postal Circle under Project Arrow. Till date, 79 post offices in Orissa have been covered under Project Arrow. All post offices under Project Arrow are computerized with Multipurpose booking counter machines and have facilities for booking of electronic money orders. Details of post offices covered under Project Arrow in Orissa Postal Circle are given in the Statement.
