#### Rural Industries in Bihar

3716. SHRI MOTIUR RAHMAN: Will the Minister of AGRO AND RU-RAL INDUSTRIES be pleased to state:

- (a) the details of Agro and Rural industries in Bihar;
- (b) the investment made in those industries;
- (c) the total turn over of those industries during the last year; and
- (d) the proposals for increasing the Agro and Rural industries in Bihar?

THE MINISTER OF AGRO AND RURAL INDUSTRIES (SHRI MAHABIR PRASAD) (a) Agro and rural industries in Bihar have been classified into seven broad groups as per details given in Statement I (see below).

- (b) The investment made in village industries set up in Bihar under the Rural Employment Generation Programme (REGP), implemented through the Khadi and Village Industries Commission (KVIC) and banks, as on 15 January 2005 are given in Statement II (see below).
- (c) The total turnover (sale value) of village industries, including those set up under the REGP, in Bihar during 2004-05 (up to 15 January 2005) is Rs. 224.82 crore (provisional).
- (d) During 2003-04 and 2004-05 (up to 15 January 2005), 88 and 133 projects respectively were set up under the REGP. For the current year, 2005-06, the target of setting up of 450 village industry units in Bihar has been fixed under the REGP. The steps initiated for better performance in the Bihar under the REGP include communication of district-wise and bank-wise target of REGP well in advance, allocation of 40 per cent of target for food and agro-based industries, earmarking of 30 per cent of target for women beneficiaries, providing support services under backward-forward linkages, earmarking of 25 per cent of stalls in each exhibition for the weaker section beneficiaries, including women entrepreneurs, etc. In addition, KVIC has also opened a Rural Industries Consultancy Service (RICS) Cell at its State Office at Patna to guide the entrepreneurs in setting up village industry units.
