## (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (PROF. K.V. THOMAS): (a) Yes, Sir. International Food Policy Research Institute (IFPRI) has brought out a Global Hunger Index (GHI) Report in October, 2010. The index is a combined measure of undernourishment, underweight in children under the age of five and mortality rate of children under the age of five. The index ranks countries on a 100-point scale, with 0 being the best score (no hunger) and 100 being the worst. The GHI score for India in 2010 is 24.1 against the score of 31.7 in 1990 which is lower by approximately 23.9%. GHI Score for China in the corresponding period is lower by approximately by 48.2%.

(b) and (c) As per the said Report, the economic performance and hunger levels are inversely correlated. The Report *inter-alia* also indicates that India is among the countries where hunger levels are considerably higher than its Gross National Income (GNI) per capita would suggest. In India, for example, high 2010 GHI scores are driven by high levels of child underweight resulting from the low nutritional and social status of women in the country.

The GHI Report, 2010 does not reflect impact of the latest economic events. Since the data in the Index are of 2003-08, they do not reflect India's latest performance. Further, child mortality and incidence of underweight in children are not necessarily as a result of only hunger.

THOMAS): (a) Details of damaged/non-issuable foodgrains accrued in Food Corporation of India (FCI) godowns during the financial year 2009-10, as reported by F.C.I. given in the Statement (See below).

(b) to (d) F.C.I. has reported that after conducting inquiry, action has been taken against 28 delinquent officers/officials during the year 2009-10 for damage of foodgrains.

## Implementation of Food Security Act

2708. SHRI PARIMAL NATHWANI: Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the details of the main features of the Food Security Bill;
- (b) how far the Bill takes care of the people below the poverty line in both urban and rural areas;
- (c) whether implementation of the Act will result in substantial increase of foodgrains outgo from PDS; and
  - (d) if so, its implications on food economy?

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (PROF. K.V. THOMAS): (a) to (d) The Government is committed to enact a National Food Security Act (NFSA) which, *inter alia*, envisages entitling every family below poverty line to a certain quantity of Food grains each month at subsidized prices.

The National Advisory Council (NAC) has made certain recommendations on 23.10.2010 on the proposed National Food Security Bill.

The recommendations of NAC and other stakeholders will be considered by the Empowered Group of Ministers (EGoM) constituted to consider various issues regarding the proposed law on food security. Based on directions of EGoM, the draft Bill would be prepared and further action taken.
