areas of the North Eastern States and to broadcast programmes, relevant to the area, in local dialects.

The Press Information Bureau is implementing some special schemes during the Ninth Plan such as, Computerization of the activities of PIB, opening of branch offices of PIB in tribal areas and coordinating and organising of press parties to tribal areas.

During the current Plan period, Directorate of Fie id Publicity has already opened four new Field Publicity Units in the North hast and three more Field offices are proposed.

The Song and Drama Division is operating Sensitive Area and Inner Line Publicity Scheme and Tribal/Desert/Hilly Areas Publicity Scheme in the North-Eastern Region.

(b) to (d) The main reasons for which some of he remote areas of (he NER remained uncovered by the media network were non-availability of adequate resources, for providing basic infrastructure, shortage of posts/staff, hilly and difficult terrain and local law and order problems. During"the current 9th Plan, it is proposed to strengthen the existing units and open more field offices of the Media Units in the North Eastern Region in order to expand the coverage of areas. The existing facilities will also be put to optimal use.

AIR and Doordarshan are implementing a redeployment scheme to effectively man and operate their installations.

## Doordarshan towers for expansion of Communication Services
