- (c) whether it is also a fact that due to delay in granting approval, many coal projects are pending for commencement; and
  - (d) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF COAL (SHRI SHRIPRAKASH JAISWAL): (a) to (d) A number of Coal projects of the public as well as private sector are being scrutinized and processed at various levels including the Ministry of Environment and Forests, DGMS, various agencies at the State Government level and also in the different Company Boards. Getting the projects approved at appropriate levels for commencement of production after getting all the necessary clearances is a continuous process.

## **Export of coal**

2800. SHRI DHIRAJ PRASAD SAHU: Will the Minister of COAL be pleased to state:

- (a) whether Government has exported coal to various countries during the last three years;
- (b) if so, the reasons therefor and the quantity of coal exported during the said period, year-wise and country-wise; and
  - (c) the steps taken to improve production and export of coal?

THE MINISTER OF STATE OF THE MINISTRY OF COAL (SHRI SHRIPRAKASH JAISWAL): (a) and (b) Coal India Ltd. (CIL) has been exporting a nominal quantity of coal over past few years only to one neighboring country *i.e.* Nepal based on request received from Government of Nepal. Year-wise quantity of coal exported to Nepal is as under:—

(c) While a series of steps including allotment of 208 coal blocks to private/public companies to add new capacity in the coal sector have been initiated by the Government, however, due to excess domestic demand, the exports of coal from the country can not be increased.
